Many parents assume "not my kid" or lack understanding of how online life impacts mental health and career. Without parent partnership, district efforts can only go so far.

Restricting isn't teaching

Today's kids will live in a dual world where digital spaces shape their education, relationships, and identity. Bans alone can't prepare them — students need guidance to navigate an ever-evolving tech landscape safely and responsibly.

The 5 critical gaps and how your organization can address them

1 Online conflict persists, even with bans

The challenge: Phone bans may reduce disruption in the classroom, but most damaging activity — bullying, sextortion, and grooming — occur after hours. These threats will still impact school resources, safety, and attendance.

Kids don't just need protection they need skills

The challenge: Telling students what **not** to do doesn't equip them for the digital world they live in. They need critical thinking and real-life decision-making tools.

- Recognize emotional manipulation:
 Al can mimic friends, celebrities, and authority figures to influence behavior
 — often using flattery, urgency, or guilt to manipulate.
- Understand data privacy risks:
 Many Al tools collect and store
 what users type which can include personal details, private thoughts, and even sensitive photos.
- Spot the false sense of security:
 Al can be helpful, but it's not always accurate, ethical, or safe. Teach students to verify, question, and critically evaluate anything Algenerated.

3 Mental health crises are an inevitable factor

The challenge: The emotional toll of digital life is constant and invisible. Likes, comments, and messages carry emotional weight long after students log off.

What we're doing:

 Partnering with **Talkspace** to connect kids with Bark Phones that come preloaded with mental health resources.

- <u>Build digital resilience</u>: Teach students how to manage online rejection, comparison, and stress, emphasizing brain-based instruction.
- Strengthen SEL for the digital world:
 Apply empathy and decision-making to online experiences.
- Acknowledge 24/7 exposure: Students need strategies to unplug and reset.

4 Resilience > reactive safety lessons

The challenge: Safety curriculum is outdated in months. Reactive programs can't keep up with how fast tech — and risk — evolves.

The challenge: Students no longer separate their online and offline selves. Conflict travels seamlessly across both — and educators may not see it coming since digital behavior is more difficult to observe.

- Emphasizing ethical use, not just etiquette, in digital citizenship content.
- Training educators to recognize digital-origin challenges.
